

Regular Session Minutes of the Council of the City of Dora, Alabama

March 25, 2014

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:10 p.m. We were led in prayer by Richard Lovelady. The Pledge of Allegiance was led by Mayor Randy Stephens.

The meeting was called to order by Mayor Randy Stephens. Roll call was taken by Marcy Brown. Present at the meeting were Robert Busby, Richard Lovelady, Clyde Nix, Betty Sanders, Gary Thomas, and Hezekiah Walker. Absent was George Sides, Jr. A quorum was in attendance.

The minutes of the March 11, 2014 Regular Meeting was reviewed. A motion was made by Robert Busby to accept the minutes as written. The motion was seconded by Clyde Nix. All in favor and motion carried.

Old Business

Item #6 – Armory Roof - Mayor Stephens updated the council on the meeting with Robert Nelson, an engineer, on the armory roof. Stated that the engineer's opinion was that it was not worth saving. Item # 10 – Resolution #3-2014 -Mayor Randy Stephens read to resolution on the alcohol licensing for Jered Heath Dodd D/B/A Horse Creek Bistro Clerk Marcy Brown stated that it would be ran in the newspaper 2 times prior to the next regular council meeting.

Item # 11 – Quotes for roofing job – Clyde Nix made a motion to approve the G & L Roofing quote to replace the roofs of the city hall, civic center and three park pavilion roofs in the amount of \$26,360.00 Betty Sanders seconded the motion.
