

Regular Session Minutes of the Council of the City of Dora, Alabama

May 26, 2015

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:00 p.m. We were led in prayer by John Skalnick. The Pledge of Allegiance was led by Mayor Randy Stephens.

The meeting was called to order by Mayor Randy Stephens. Roll call was taken by Marcy Brown. Present at the meeting were, Robert Busby, Richard Lovelady, Clyde Nix, Betty Sanders, Gary Thomas, and Hezikiah Walker. George Sides, Jr. was absent. A quorum was in attendance.

The minutes of the May 12, 2015 regular meeting were reviewed. A motion was made by Richard Lovelady to accept the minutes as written. The motion was seconded by Hezikiah Walker. All in favor and motion carried.

Old Business

- a. Clyde Nix made a motion to approve the hiring of Gardner Architects, Inc. to build and design the golf clubhouse. Betty Sanders seconded the motion.
Roll Call vote: Robert Busby – No; Richard Lovelady – No; Clyde Nix – Yes; George Sides, Jr.- Absent; Betty Sanders –Yes; Gary Thomas – No; Hezikiah Walker – No; and Randy Stephens, Yes. The motion failed. 3 – Yes and 4 – No.

Mayor Stephens was scheduling a workshop with Gardner Architect, Inc. to meet with the council and answer any questions they may have concerning the fees, design, and construction of the clubhouse.

Item # 7 – Bill List – A motion was made by Gary Thomas to approve the bill list for 5/26/2015. The motion was seconded by Richard Lovelady. All in Favor and the motion passed.

Item #8—East Walker Chamber of Commerce Annual Banquet – Richard Lovelady made a motion to sponsor a table at the East Walker Chamber of Commerce to be held on June 1, 2015 for an amount of \$150.00. Robert Busby seconded the motion. All in favor and the motion carried.

Item #9—Ordinances #8, 2015 – Clyde Nix made a motion to suspend the rules for immediate consideration of Ordinance #8, 2015 amending the original Ordinance #2, 2012 which set the rules of procedure for council meetings. Gary Thomas seconded the motion.

Roll Call vote: Robert Busby – Yes; Richard Lovelady – Yes; Clyde Nix – Yes; George Sides, Jr.- Absent; Betty Sanders –Yes; Gary Thomas – Yes; Hezikiah Walker – Yes; and Randy Stephens, Yes. The motion passed.

Hezikiah Walker made a motion to approve Ordinance #8, 2015 amending the original Ordinance #2, 2012 that set the rules of procedure for council meetings, adding the approval of the agenda to section #6. Richard Lovelady seconded the motion.

Roll Call vote: Robert Busby – No; Richard Lovelady – Yes; Clyde Nix – No; George Sides, Jr. - Absent; Betty Sanders –Yes; Gary Thomas – No; Hezikiah Walker – Yes; and Randy Stephens, No. The motion failed. 4 – No and 3 – Yes.

Item #10 – Resolution #6, 2015 Sales Tax Holiday –Robert Busby made a motion to approve Resolution #6, 2015 for the Sales Tax Free Holiday on the first weekend of August 2015. Gary Thomas seconded the motion. All in favor and the motion was carried.

Item #11 – EDKO Herbicide Proposal – Hezekiah Walker made a motion to approve the EDKO herbicide proposal. Motion failed due to lack of a second.

Item #12 – Approval of new Fireman –Clyde Nix made a motion to approve the new Fireman, Chase Gant. Gary Thomas seconded the motion. All in favor with the exception of Hezekiah Walker, who opposed. The motion was carried.

Gray Thomas made a motion to adjourn. Robert Busby seconded the motion. All in favor and meeting adjourned.
