

Regular Session Minutes of the Council of the City of Dora, Alabama

August 12, 2014

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:02 p.m. We were led in prayer by Don Cummings. The Pledge of Allegiance was led by Mayor Randy Stephens.

Item # 12 – East Walker Sewer Authority Secretary – Gary Thomas made a motion to approve the City of Dora taking over the financial books for EWSA. There were no second to the motion, motion failed.

Item # 13 – Park Requests - Richard Lovelady made a motion to purchase 11 football helmets for the park at a cost of \$671.87. George Sides, Jr. seconded the motion. All in favor and the motion passed.
