Regular Session Minutes of the Council of the City of Dora, Alabama

September 23, 2014

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 5:00 p.m. We were led in prayer by Hezekiah Walker. The Pledge of Allegiance was led by Mayor Randy Stephens.

Item # 11 – Surplus Items to bid – Clyde Nix made a motion to bid out the 1997 John Deer 7410 Tractor with a minimum bid of \$10,000, old garbage truck with a minimum bid of \$3,000, and the 1998 Jeep Cherokee with minimum bid of \$500. George Sides, Jr. seconded the motion.

Gary Thomas seconded the motion.
