

# Regular Session Minutes of the Council of the City of Dora, Alabama

October 11, 2016

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:00 p.m. We were led in prayer by Gene Smith. The Pledge of Allegiance was led by Mayor Randy Stephens.

## **Old Business**

**Item #7 - Departmental Reports** - A motion was made by Clyde Nix to approve items A-G under Departmental Reports. Gary Thomas seconded the motion. All in favor and the motion was carried.

Discussion was made on the relocation of the current trailers at the golf course so that the club house can be moved forward and not cost as much money in the excavation work. Clyde Nix made a motion to move the trailers at the golf course. Gary Thomas seconded the motion. All in favor, with the exception of Robert Busby, and the motion carried.

**Item #9 - Executive Session** - A motion was made by Richard Lovelady to leave the regular session and enter into an executive session to discuss potential litigation involving the park. Gary Thomas seconded the motion.
