

Regular Session Minutes of the Council of the City of Dora, Alabama

October 27, 2015

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:00 p.m. We were led in prayer by John Skalnick. The Pledge of Allegiance was led by Mayor Randy Stephens.

The meeting was called to order by Mayor Randy Stephens. Roll call was taken by Marcy Brown. Present at the meeting were, Robert Busby, Richard Lovelady, Clyde Nix, George Sides, Jr., and Gary Thomas. Absent were Betty Sanders and Hezekiah Walker. A quorum was in attendance.

Old Business

Item #10 – Ordinance #12, 2015 - Noise – Clyde Nix made motion to suspend the rules for immediate consideration on Ordinance #12, 2015. Gary Thomas seconded the motion.

Roll Call vote: Robert Busby –No; Richard Lovelady –No; Clyde Nix – Yes; George Sides, Jr.- No, Betty Sanders –Absent; Gary Thomas – Yes; Hezekiah Walker – Absent; and Randy Stephens, Yes. The motion failed.

Ordinance #10, 2015 (Nuisance) and #11, 2015 (Weed Control) were introduced and will be brought up at the next scheduled meeting.

Item #13 – Fire/Police Department Safety Training Class – George Sides, Jr. made a motion to approve spending \$250.00 to host the safety training class. Robert Busby seconded the motion. All in favor and the motion carried.

Item #14 – Fire Department Requests - Gary Thomas made a motion to purchase 12 sections of fire hose from the Shannon Volunteer Fire Department at a cost of \$100.00 each. Total cost is \$1200.00. Richard Lovelady seconded the motion. All in favor and the motion carried.

Gary Thomas made a motion to adjourn. Richard Lovelady seconded the motion. All in favor and meeting adjourned.
