

Regular Session Minutes of the Council of the City of Dora, Alabama

December 9, 2014

The Council of the City of Dora, Alabama met in the Dora Municipal Building at 6:00 p.m. We were led in prayer by Don Cummings. The Pledge of Allegiance was led by Mayor Randy Stephens.

Richard Lovelady seconded the motion. All in favor and the motion was passed.
